Taipei Convention

A lot of work is happening at the Rotary International level to ensure that the Taipei Convention goes ahead. Right now, ITHF does not know what decision Rotary will make nor whether the Taiwanese authorities will be willing to allow thousands of people to enter Taiwan given the health risks that might create.

Depending on what happens, ITHF will have a booth in the House of Friendship but this may be a virtual booth, a manned booth, or a hybrid of some sort.

The pre- and post-convention tours have been cancelled. The block booking of hotel accommodation in Taipei by ITHF has been cancelled. If the Taipei Convention goes ahead and you choose to attend, you will need to make your own arrangements in respect of accommodation and sightseeing tours. There will be an AGM for ITHF in June 2021. If it is possible to hold the AGM in person in Taipei, details will be provided when known. Otherwise, a Zoom or similar arrangement will be made so that the AGM can be held.

Houston Convention

While it seems a long way away, planning is underway to have a pre- and postconvention tour in 2022 when Rotary meets in Houston.
